



WIN PLACE SHOW

Show Set Up

The Producers of Penns Lane Entertainment, LLC will provide wagering funds to each team of contestants per episode.

The dollar amount of wagering funds given to each team of contestants will increase as the contestants advance to each succeeding round.

Each team of contestants will keep the winnings earned from wagering in each episode. The winnings will be divided equally, 50% to each contestant in lieu of receiving an appearance fee.

The winning team from each episode advances to the next level.

Contestants that do not advance to the next level will have an opportunity to return to a future episode as a contestant. These contestants will be selected by the Producers of WIN PLACE SHOW based on their performance and abilities.

The season finale will pit the TWO contestants from the winning team in episode nine against each other determining the season winner of Win Place Show.

The producers of WIN PLACE SHOW reserve the right to add an additional horse racing wager, such as an exotic wager (exacta, trifecta, etc.), to the final episode.

The winning contestant of the final episode will receive a cash prize and/or other prizes determined by the Executive Producers at Penns Lane Entertainment, LLC, the producers of WIN PLACE SHOW.

Contest Rules

The Producers of WIN PLACE SHOW and its Host, Jimmy “The Hat” Allard will pre-select three (3) races from the Del Mar Thoroughbred Club daily racing program for the contestants to wager on. The contestants will be notified of these races approximately two (2) hours before the start of the first live race.

The teams(s) MUST place a wager(s) in EACH of the pre-selected races.

Each team of contestants can only wager with the funds provided by the Producers of WIN PLACE SHOW.

ALL of the original funds provided by the Producers must be wagered in the pre-selected races.

Each team of contestants can only make win, place and/or show wagers in each of the three (3) pre-selected races. Exotic wagering (exacta, trifecta, etc.) are excluded unless stated by the Producers WIN PLACE SHOW for the final show.

All wagering tickets will be collected from the contestants and held by the Producers of WIN PLACE SHOW until all three pre-selected races are run.

Each team is provided with a professional Handicapper for each episode as a Team Captain for advice and instruction only. The team’s professional Handicapper will not provide nor be allowed to make the racing picks for each team (contestants).

The team with the highest total amount of winning wagers, including the original funds provided by the Producers is determined to be the winner and advances to the next round/stays in the competition. The Producers of WIN PLACE SHOW and the show Host, Jimmy “The Hat” Allard, will process, calculate and verify the earnings of each team to determine the winner.

Each team (contestant) will be provided data, information and access necessary to determine their wagering philosophy (that is available to the Producers). No third-party wagering programs, electronic or print will be allowed.

In the event of a tie, the Producers of WIN PLACE SHOW, and show Host, Jimmy “The Hat” Allard, will select one additional race and wagering amount to determine the winner. The team with the highest earnings will be the winner.

All other rules will apply.

If there is an unforeseen event with any of the three (3) pre-selected races, the Producers of WIN PLACE SHOW will determine another mechanism or will conclude the contest based on the races already completed.
